High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

### We are creating a new habitats

Due to unforeseen circumstances, we are continuing our work near Hints to create new habitats for wildlife as well as completing tree planting. We will be continuing these works until February 2021.

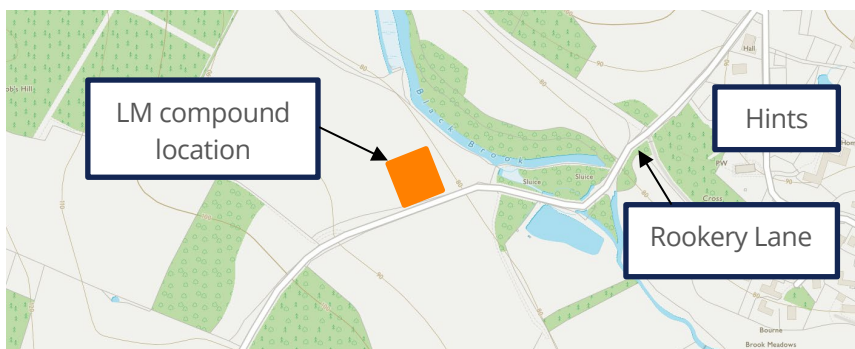
While we conduct this work, we will be using our compound off Rookery Lane near Hints. Once we complete our works we will demobilise and remove this compound.
