High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

We are constructing two bridges under the A38 to take HS2 beneath the main carriageway and slip roads. Traffic management is required to carry out the works, which will involve narrow lanes and speed restrictions for the duration of the work, along with lane closures and full carriageway closures when required.

The work we will be doing

We will be undertaking preparatory works on the A38, in advance of the construction of the HS2 line.

These works will include

- Hardening of the central reservation
- Installation of a new temporary vehicle restraint system to protect staff in our working area
- Narrow lanes
- Reduction of the speed limit to 40mph
- Speed detection cameras will be installed

When these works will take place

These works will take place over eight weekends between Friday 15 October 2021 and Monday 6 December 2021.

Our working hours, during each weekend, will commence at 8pm each Friday and end at 5am each Monday morning.

We may be on site up for one hour before and after to set up and take down our equipment.

(These works are subject to consent).

These works will take place over eight weekends between Friday 15 October 2021 and Monday 6 December 2021.

We may be on site up for one hour before and after to set up and take down our equipment.

Some noise and vibration generated from the work we are completing.

The use of additional lighting in our working area.

Clear signage in place to direct road users through the diversion.

What we will do

Inform you in advance of any changes to the date shown.

Keep all sites safe and secure.

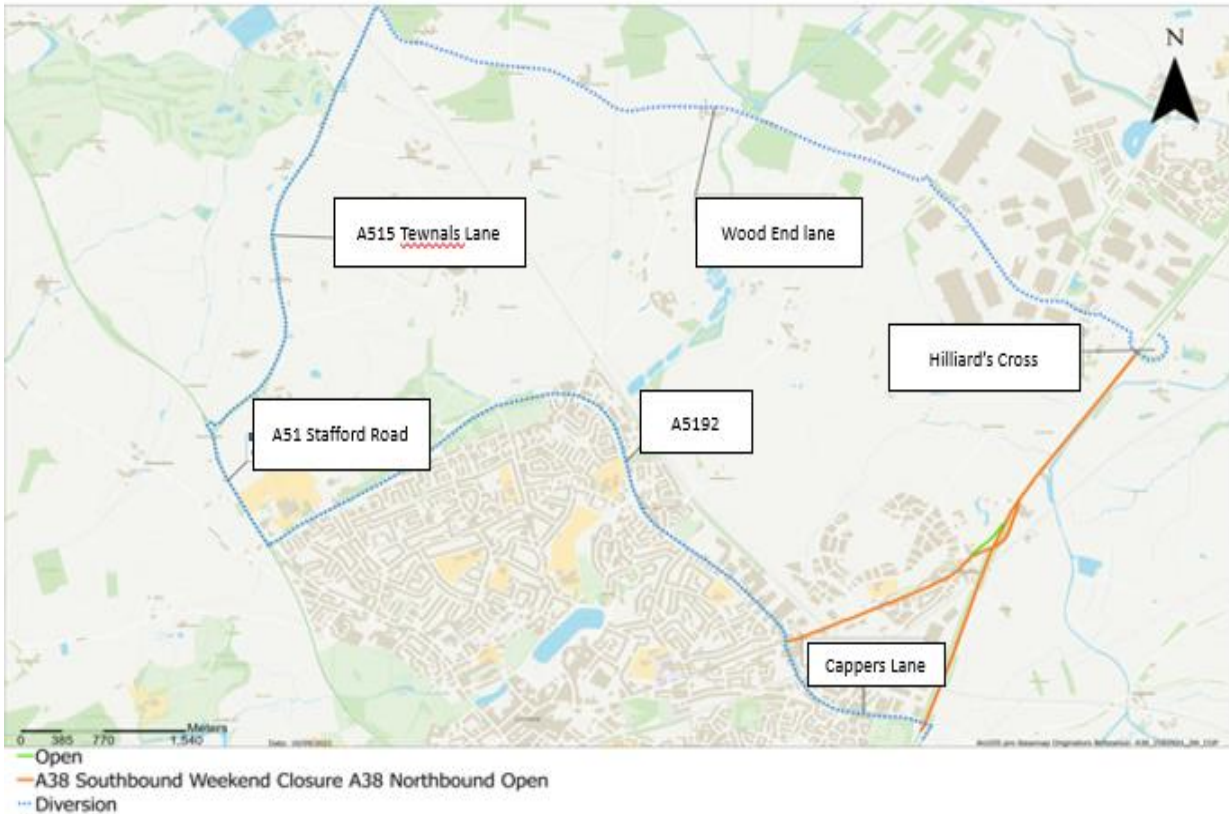
