High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be erecting a temporary vehicle restraint system to protect staff in our working area and close the eastbound layby permanently. We will also be installing new fencing.

For the safety of the construction team and road users this will mean both lanes of the A5 being closed for one night.

When these works will take place

These works will mean that both lanes of the A5 eastbound carriageway will be closed overnight for **one night on Thursday 28 October 2021 from 8:00pm to 6:00am.**

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority.
