High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We need to undertake surveys that will record the underground drainage network. The information acquired from these surveys will feed the design of the proposed new alignment of the A453 Sutton Road to accommodate the new high-speed railway.

When these works will take place

To complete these works safely and efficiently we will install temporary traffic management as follows:

- Daytime lane closure with temporary traffic lights on A453 Sutton Road / Drayton Lane between 24 July to 28 July from 9.30am until 3.30pm.
- Daytime closures of Drayton Lane between **31 July to 11 August** from **9.30am until 3.30pm** (Not including weekends)

A clearly signed diversion route will be in place over this period with advance signage in place to help inform motorists of the closure.


