



# Notice of overnight closures on A5 Hints Bypass

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

We are working along a section of the A5 Hints Bypass, to prepare for the construction of the bridge that will enable the HS2 railway line to pass under the A5. To improve safety for road user and our workforce we will have temporary overnight carriageway closures, between Weeford Interchange and Fazeley, to install:

- Speed cameras on both the east and westbound carriageways, and
- Temporary barriers in preparation for future construction activities.

## When we will have the overnight closures

Our closures will take place on the following nights:

- **A5 Westbound overnight closures:** Friday 1 and Saturday 2 April
- **A5 Eastbound overnight closures:** Sunday 3 and Monday 4 April

The carriageways will be closed from 9pm each evening and reopen at 5:30am each morning. Our operatives may be on site up to one hour before and after our working hours to set up and secure equipment.

During the overnight closures, there will be a clearly signed diversion route in place (see map on page 2).

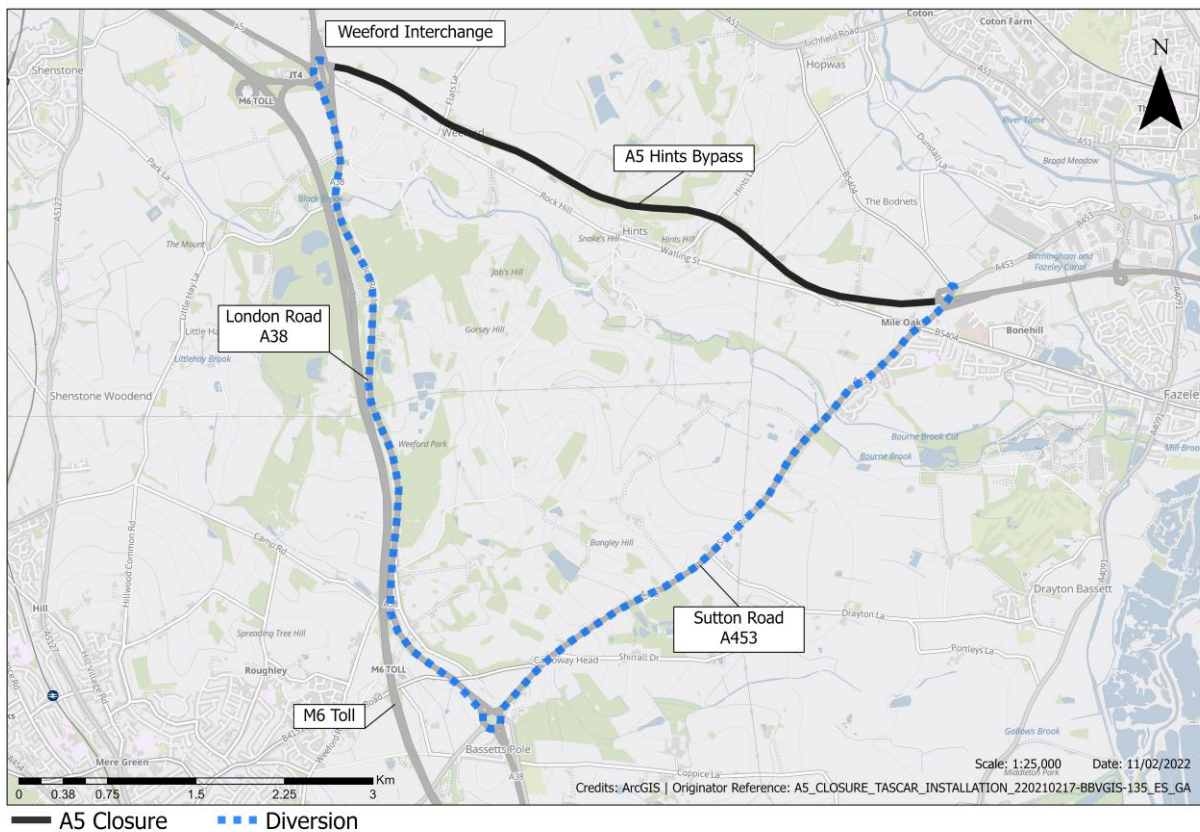

## Map of road closure and diversion route

The map below details the A5 Hints Bypass closure and diversion route that will be in place during the overnight closures.

**A5 Eastbound diversion route:** traffic will be diverted along the A38 London Road to Bassetts Pole roundabout and onto the A453 Sutton Road.

**A5 Westbound diversion route:** traffic will be diverted onto A453 Sutton Road to Bassetts Pole roundabout and onto the A38 London Road.

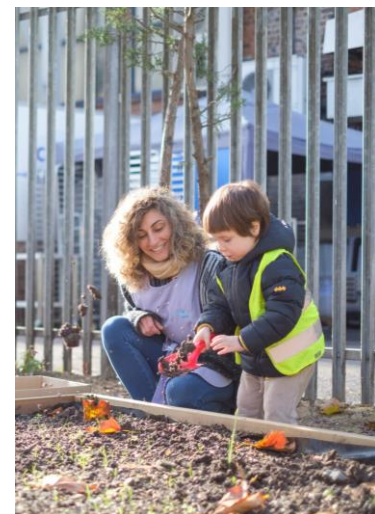
## About our Community and Business Funds
