



# Notice of temporary closure of Rookery Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

We will be carrying out topographical surveys along Rookery Lane. To complete the surveys a team of engineers will visit the location and record what is present in the area. This will provide us with information on land features around Rookery Lane, which we need to assess as we develop our construction plans. For the work to be completed in a safe environment, we will close Rookery Lane.

## When these works will take place

These works will take place on 31 January from 9.30 am to 3.30 pm. We will close Rookery Lane to complete these works (see map on page 2). Access to residents and businesses will be maintained during this time. We will use School Lane as an access to Rookery Lane, for a small number of 4x4 vehicles and a tractor, to install the traffic management and complete the works.

## HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

Our working hours will be 9.30 am to 3.30 pm (Mon-Fri).

Our workforce may be on site one hour before and after to set up and take down our work equipment.

Rookery Lane will be closed while we complete these works.

We will install signage on the roadside.

Some low level noise will be generated from the work we are completing.

Keep all sites safe and secure.
