High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we are doing

We are creating a safe, controlled crossing, giving priority, for users of Swinfen and Packington Bridleway 7, Knox Graves Lane. Where haul roads cross highways, bridleways and public footpaths, controlled crossings are put in place to ensure public safety. A gated crossing point is being created, which will be manned 8am to 6pm weekdays.

We will construct a haul road which will be used by our construction vehicles. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site. Haul roads are Balfour Beatty Vinci's preferred logistical transport link, as they reduce the number of vehicle movements interfering with the existing local road network and provide the greatest possible control over works activity.

When these works will take place

These works will take place on July 1 2021 for a 1 day. Our working hours will be 8:00am to 6:00pm, our workforce may be on site one hour before and after to set and take down our work equipment.
