High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we are doing

We will be completing ground penetrating radar surveys to help us understand more about the ground conditions where we are building the railway.

## When will we undertake these works

Temporary traffic lights will be in place from Monday 22 November 2021 until Friday 3 December 2021 excluding weekends.

Our working hours will be 8:00am until 6:00pm, a lane closure with temporary lights will be in place on Watling Street.

Our workforce may be on site one hour before and after to set up and take down our equipment.

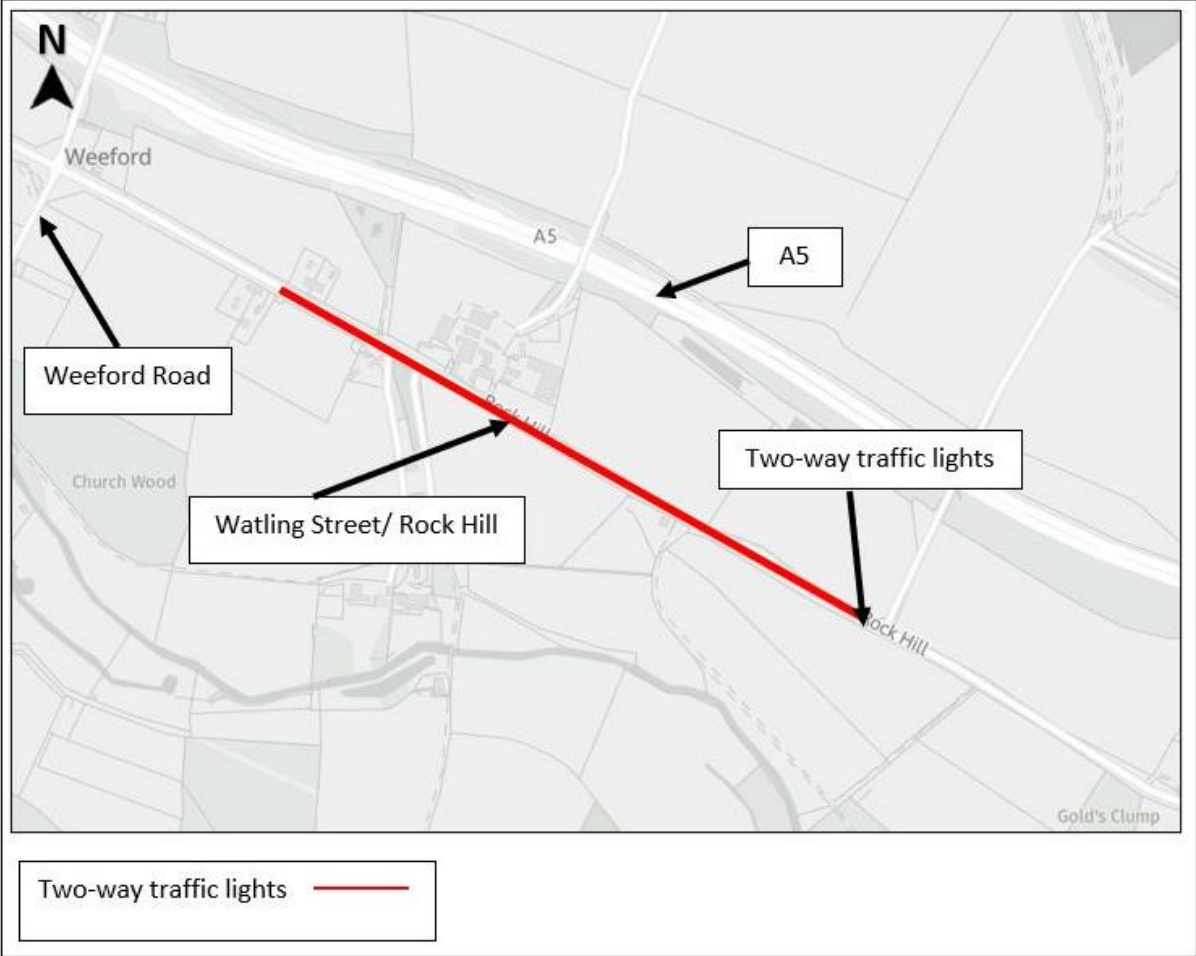
